- Promoter:** Whites Group Pty Limited ABN 25 001 845 478 ("Promoter" or "Whites") is conducting this promotion in accordance with these Terms and Conditions.
- Promotional Period:** The promotion runs from 16 May 2026 to 30 June 2026 ("Promotional Period").
- Eligibility:** This promotion is open to Australian residents aged 18 years or over ("Qualifying Recipients"). Employees (and their immediate families) of the Promoter, AIRR and agencies associated with this promotion are not eligible to participate. Immediate family includes spouse, de-facto spouse, ex-spouse, child or step-child, parent, step-parent, grandparent, step-grandparent, sibling, step-sibling, aunt, uncle, niece, nephew or first cousin.
- Qualifying Purchases:** Qualifying Recipients must purchase Whites Rural and/or Murray Australian-made fencing products valued at \$5,000 or more (including GST) in a single or multiple transactions during the Promotional Period. Purchases must be made at participating AIRR outlets. Custom-made or made-to-order Murray products are excluded. Invoice values may be combined across the Promotional Period.

7. **Claim Process:** Following submission of the online redemption form and validation of invoices, a claim form will be issued to Qualifying Recipients after the conclusion of the Promotional Period. The form will specify the final number of jerseys each Qualifying Recipient is entitled to claim based on their validated purchase(s). All forms must be completed in full and submitted by 4.00pm AEST on 14 July 2026, unless otherwise agreed in writing by the Promoter. Incomplete or late claims will be deemed invalid. The Promoter's validation of qualifying spend and final claim numbers is final.
8. **Prize Details:** The prize is a sports jersey valued up to \$159.99 (including GST) RRP. Jerseys will be sourced from major Australian retailers. Available sports codes include AFL, NRL, A-League and Rugby Union, including associated women's leagues.
9. **Prize Selection & Availability:** It is the responsibility of the Qualifying Recipient to ensure all claim details and size selections are correct. Once submitted, selections cannot be changed. If a selected jersey is unavailable, the Promoter reserves the right to substitute a prize of equal or greater value, subject to applicable legislation.
